Upon receipt of this information, IPE request non-matriculated UW student status on your behalf. As soon as your UW student number has been issued, IPE will send it to you via email. You will then need to take the following steps to establish your UWnet ID and to gain access your MyUW personal page:

- 1) Contact the UW Registration Office (225 Schmitz Hall, 206-543-8580) to request a Private Access Code (PAC). You will need to have your UW student number ready.
- 2) Go to <https://uwnetid.washington.edu/newid/> to establish your UWnetID and password. You will need to have your last name, date of birth, UW student number and PAC ready.
- 3) Go to <http://myuw.washington.edu> and type in your UWnetID and password to access your MyUW personal page.

Your MyUW personal page is a secure webpage that contains your personal student information at the UW. Here, you will find information regarding your program payment charges, program charge due dates and possible methods of payment. You will also be able to view your registration status (upon submission of your Concurrent Enrollment forms) and your grades (upon completion of the program).

You will be assessed a non-refundable \$200 non-matriculated student application fee for this process.

In addition, you will need to turn in the concurrent enrollment and medical forms to IPE in order to enroll for your departmental program. These forms can be downloaded from the IPE website: <http://ipe.washington.edu> and should be submitted to IPE by the required deadline. A \$25 late fee will be added to any and all late CEs.

Once your concurrent enrollment form has been received by the IPE office, IPE will charge your MyUW student account a \$200/quarter or \$300/semester IPE fee and will register you for FSTDY for your study abroad.
